Dear friends of the Balkan rivers,

Since our last newsletter, we considerably intensified our fight for the creation of a **Vjosa National Park** and received overwhelming prominent support – from EU institutions to Hollywood celebrities. The new **short film “Vjosa Forever”**, produced by Patagonia, and a visual action that we organized in four European capital cities helped to bring the issue on an international stage. Despite all the support, the Albanian government seems determined to avoid the establishment of a Vjosa National Park and create a nature park, instead. This would provide much weaker protection, exclude all tributaries and keep the door open for future dam projects and other big infrastructure projects, such as the new airport near Vlora and tourist resorts near Vjosa’s mouth. Meanwhile, general elections are coming up on April 25 and the Vjosa has become a central issue in the election campaign. 94% of Albanians are in favour of the Vjosa National Park – will they vote for the Vjosa in this election? **Find out what YOU can do to contribute to Europe’s first Wild River National Park** in this newsletter!

#VjosaNationalParkNow! In February, we submitted a detailed [proposal for the creation of the Vjosa National Park](#) to the Albanian government. Since then, we do everything in our power so that decision makers can’t simply sweep this proposal under the table, urging them to declare the Vjosa in Albania Europe’s first Wild River National Park. On the occasion of this year’s World Water Day, we cloaked the foreground of globally recognised monuments in Paris, Berlin, Brussels, and Tirana with the demand [“Vjosa National Park Now” in 7m fabric letters](#). We also held a press conference in the [Brussels Press Club](#) and handed over a collage of the visual action to EU Commissioner of the Environment Virginijus Sinkevičius, who then [spoke out in support](#) of the Vjosa National Park. 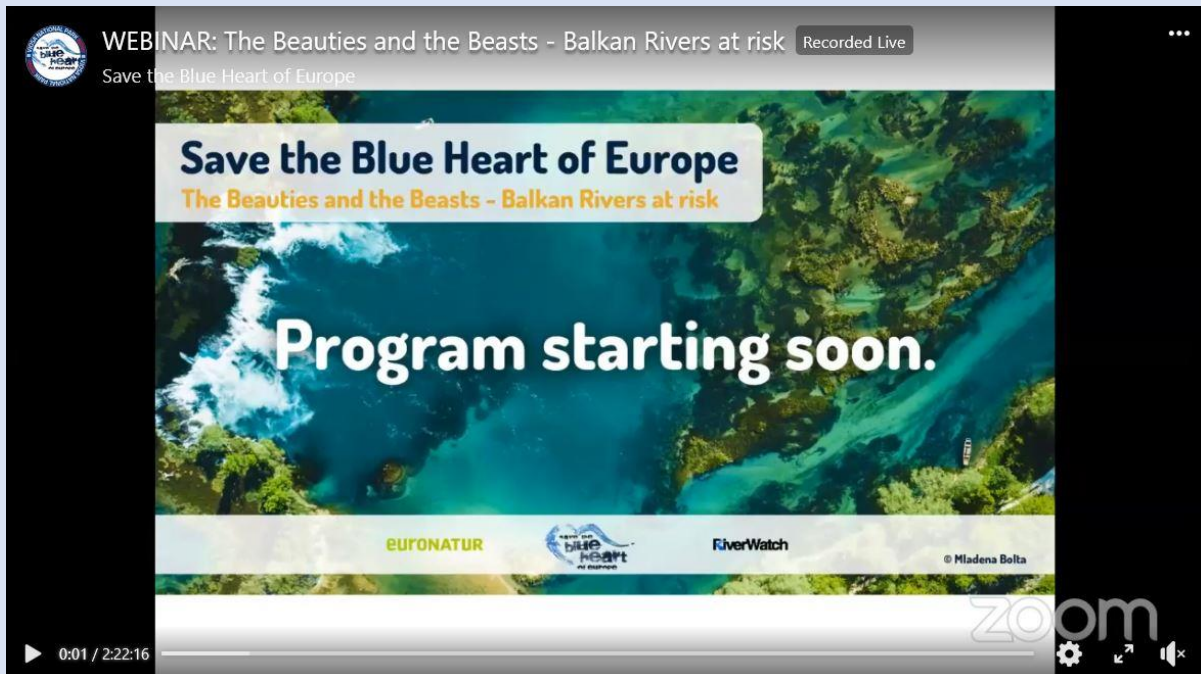

Kelag again! The scandal about the actions of Austrian Kelag Energie in Kosovo continues: Kelag's subsidiary in Kosovo "Kelkos" sued activist Shpresa Loshaj for €100,000. This looks very much like a SLAPP case – a strategic lawsuit against public participation – which, according to European Parliament's rapporteur for Kosovo, are on the rise in the country. It is an unacceptable attempt to shut down civil society and push through highly contested hydropower projects. Shpresa won't be intimidated and we will support her all the way! [MORE](#)

Good news from Bosnia and Herzegovina! Following the Federation of BiH, the Republika Srpska now also wants to end the hydropower boom. The Assembly in Banja Luka [adopted a declaration](#) in mid-February to 1. end subsidies of hydropower, 2. review all existing hydro concessions, 3. put a moratorium on new concessions.



Prominent Artists for Balkan Rivers! Rivers inspire arts – and artists stand up for their protection. Recently [Igor Paspalj](#), who was named Best Guitarist of the World in 2020, joined our struggle for Balkan Rivers. Furthermore, Bosnian director and supporting Artist for Balkan Rivers [Jasmila Žbanić](#) was nominated for two Oscars for her film "Quo Vadis, Aida?". Last October, she spoke up about Bosnian rivers and against their destruction in the N1 Bosna i Hercegovina interview.



Spotlight on Gvozdacka River! The Gvozdacka river is a gorgeous mountain river in the region of Kraljevo/Serbia, within the special nature reserve "Goc Gvozdac". This biodiversity hotspot hosts 715 plant species, 317 insect species, 129 bird species, 20 species of amphibians and reptiles as well as 27 species of mammals. The construction of several small HPPs is planned on the Gvozdacka River, which flows through the reserve. Local population and the manager of the protected area strongly oppose these projects. Serbian Blue Heart partner Right to Water ([Pravo na vodu](#)) is fighting to preserve all rivers in the Kraljevo region.
